

Use-of-Force Annual Review 2022

Of the arrests made by Beaufort County Sheriff's Office deputies in 2022, there were 20 incidents in which force was used to effect an arrest.

Altogether, 26 deputies were involved. Of the 20 documented incidents, nine (9) involved more than one Sheriff's Deputy. Six (6) deputies were involved in two (2) incidents.

Of the 20 incidents:

- One (1) involved a juvenile during school hours
- 13 reports stated no injuries to defendant or deputy involved
- Seven (7) reports stated minor injuries to defendant to include but not limited to scrapes, bruises, lacerations etc. due to resisting arrest
- Three (3) reports stated a deputy(s) were injured due to defendant resisting arrest

All 20 incidents were found to be in compliance with the Sheriff's Office standard operating procedures for use of force.

TECHNIQUES USED

There were 12 incidents where a combination of techniques were utilized. A review of the incidents shows each of the incidents started with minimum force and escalated under the Use of Force Contimuum until compliance with lawful orders was achieved. The review also revealed in nearly every one of these incidents, the initial technique was ineffective.
